Reasonable Distance

Fraud and Abuse Control Activities

We currently have two types of referrals used to refer cases to our Special Investigative Unit. They are as follows:

- 1.) Absent Parent Referral: If a parent abruptly leaves the home with no forwarding address a parent referral is made to the Special Investigations Unit in an effort to determine if the absent parent is in the child's home.
- 2.) FEDS Investigative Referral: A front end detection referral is made for non-services cases when the FA case is opened. For services of this nature a referral is made based on risk factors.

These factors include but are not limited by: moved to Rensselaer County within the last three months, prior history of fraud, application inconsistent with prior case, apparent forgery, P.O. Box without adequate explanation, or inconsistent billing information.

Describe the sampling methodology used to determine which cases will require verification of an applicant's or recipient's continued need for child care, including, as applicable, verification of participation in employment, education, or other required activities.

The information received as a result of a fraud referral is one method the Department uses to determine if further verification is needed to determine eligibility. There are also risk factors associated with cases that would prompt further investigation. Examples are: parents who switches jobs often or who continuously hands in letters from their employers versus copies of pay stubs. Other risk factors are: prior history of fraud, over-payments, inconsistent household composition, returned mail, inconsistent absent parent information, unable to contact at work, questionable documents, in general any inconsistencies would warrant additional verification. Based on the above risk factors the employers would be contacted, a fraud referral would be made, contact to collateral agencies, or a face to face meeting would be arranged. This method of recognizing "red flags" and initiating further investigation, results in quality control beyond the normal eligibility determination.

Child care subsidy attendance forms will be compared with adult and child care food program (CACFP) inspection forms for all providers that participate in CACFP to verify that child care was actually provided on the days listed on the attendance forms. The Capital District Child Care Coordinating Council will secure the inspection form records from providers that participate in CACFP and meet with the supervisor of the day care unit to compare them with the subsidy attendance records. This will be done quarterly with all providers that participate in CACFP and care for subsidized children.

The district will include a release form in the enrollment packets it distributes to parents which will allow the Rensselaer County Department of Social Services to conduct a check of the local child welfare records related to the child care attestations for the sole purpose of verifying the accuracy of the information submitted to the parent/caretaker per 18 NYCRR (f)(7)(ii). The individuals specified in question #2 above will be asked to sign the release.. The records check will be required only for the types of child care specified in question #2 and will be required only to persons in the roles specified in question # 2.

The signed release(s) specified in question #2 is/are *required*, for all persons in the roles, for the enrollment packet to be considered complete. If any of the individuals checked in question #2 above refuses to sign the release, which would allow Rensselaer County Department of Social Services to review only the existing local child welfare records related to the child care attestations, the enrollment package will be considered *incomplete* and the enrollment process cannot move forward and will be *withdrawn* by the enrollment agency in accordance with State policy.

The local district will conduct the check of the local database to determine whether an individual checked in question #2 above is an indicated subject of a child abuse or maltreatment report. When the local records check reveals that an individual specified in question #2 above is an indicated subject of a child abuse or maltreatment report the proposed child care provider will be required to submit to Rensselaer County Department of Social Services a copy of the written statement provided to the parent/caretaker concerning the indicated incident(s). This statement must be signed by the parent/caretaker acknowledging receipt of this information and the parent/caretaker's wish to use this child care provider.

If the information regarding the indicated child protective report submitted by the provider does not substantially correlate with the information obtained during the local records check related to the child care attestations, the Rensselaer County Department of Social Services will notify the provider that he or she has ten (10) calendar days to clarify the discrepancies in the information submitted to the district and parent/caretaker. Within the ten (10) calendar day period the provider must submit information to Rensselaer County Department of Social Services and the parent/caretaker that either substantially correlates with the information obtained by the district's local database check of the records related to the child care attestations or the provider submits information to the district which documents that the information obtained from the local database check of the records related to the child care attestations is inaccurate. If the provider fails to clarify the discrepancies the Rensselaer County Department of Social Services will notify the Enrollment Agency that the additional standard *has not been met*.

If the information regarding the indicated child protective report submitted by the provider to the parent/caretaker and the local district correlates with the information obtained from the local database check and the parent/caretaker still chooses to use the provider, the Enrollment Agency will be notified that the additional standard *has been met*.

Parents are required to notify the district and the provider of planned breaks in service so that payment is suspended but the child's slot is held.
